The Virgin Islands Department of Education (VIDE) Fiscal Federal Unit has a bi-monthly fiscal meeting for all programs that utilize federal funding. The Individuals with Disabilities Act (IDEA) program is represented by the State Office of Special Education, State Director and Program Manager. Part of preparing for the meeting requires monthly meetings with the LEAs to discuss their major projects and activities including the preparation of a 2-3 year forecast so that we can prioritize and plan effectively how best to support Districts' initiatives. The Federal Grants Office requires federal programs to submit a yearly spending plan on how the funds will be budgeted and utilized. Weekly updates are provided to the State and LEAs on grant expenditures, obligations and balances.

¹Each State may reserve for each fiscal year not more than the maximum amount the State was eligible to reserve for State administration under this section for fiscal year 2004 or \$800,000 (adjusted in accordance with 20 U.S.C. 1411(e)(1)(B)), whichever is greater; and each outlying area may reserve for each fiscal year not more than 5 percent of the amount the outlying area receives under 20 U.S.C. 1411(b)(1) for the fiscal year or \$35,000, whichever is greater.
